ACTION TAKEN REPORT OF THE INSTITUTION

ACTION TAKEN REPORT BASED ON STUDENTS' FEEDBACK

Students feedback on syllabus and teaching-learning is taken, analyzed and presented before the Management and IQAC (Internal Quality Assessment Cell) for necessary action to be taken wherever needed. The action taken were as follows-

- 1. Faculty members were advised to practice a student friendly approach in teaching through mentoring.
- 2. The College has been practicing Guest Lectures, Invited and Extension Lectures by the Subject Experts and Professors from National and International level and conducts Workshops for practical knowledge.
- 3. Syllabus modification and suggestions for update as per the requirement of the concerned subject departments are sent to the Board of Studies, University of Rajasthan, Jaipur.
- 4. Addition of new text and reference books in the Library to meet the requirements of the growing number of students.
- 5. As per the need of the present time, additional Skill Enhancement Certificate and Diploma Courses are offered to the students.
- 6. More field visits, internships and interactive / hands on Workshops were conducted in the context of experiential learning.

ACTION TAKEN REPORT BASED ON FACULTY FEEDBACK

The suggestions received from the faculty members are forwarded to the Management and IQAC-Internal Quality Assessment Cell for record and appropriate action to be taken. They are as under-

- 1. On syllabus updation and modification, recommendations received from all the Heads of programmes / courses were forwarded to the respective Board of Studies, University of Rajasthan Jaipur.
- 2. Experiential learning through Visits, organizing Workshops, hands on Training and Guests/ Extension Lecture are regularly conducted by all the departments as per the requirement of the subject.
- 3. Add on Skill Development Courses have been introduced to prepare the young minds fit for the present day working dynamics.
- 4. More emphasis on Student Research Projects.

ACTION TAKEN REPORT BASED ON EMPLOYERS' FEEDBACK

- 2. Professional Course counseling process were made more regular through interactions and conducting seminars.
