MEMORANDUM OF UNDERSTANDING

Between

KANORIA PG MAHILA MAHAVIDYALAYA, JAIPUR

And

CENTRE OF ENVIRONMENT AND DEVELOPMENT STUDIES, JAIPUR

This Memorandum of Understanding (hereinafter MOU) is made between Department of Economics, Kanoria PG Mahila Mahavidyalaya, Jaipur, Rajasthan on the one part and The Centre of Environment and Development Studies (hereinafter CEDS), Jaipur, Rajasthan, on the other part (who for the purpose of this MOU are hereinafter individually referred to as 'PARTY' and collectively referred to as the 'PARTIES').

The parties have discussed the field of common research interests and allied activities between the two institutes; have decided to enter into collaboration for three years in the areas of education, training and research.

Kanoria PG Mahila Mahavidyalaya has completed 57 years of dynamic journey with an aim to educate, emancipate and empower young women of Jaipur. The college exists in the aesthetic environs of Jawahar Lal Nehru Marg established in 1965, by Late Bhagirath Ji Kanoria as the first institution of higher education for women through grant- in - aid from Government of Rajasthan and affiliated to the University of Rajasthan, Jaipur. Moving forward in its 57 years of luminous journey, the college has emerged as one of the leading institutions not only in Jaipur but also in the State of Rajasthan. With a view to impart education the college aims at disseminating not only knowledge and facts but also emphasizes on value based holistic development. In the same year the Department of Economics was established to offer in-depth knowledge of Economics as a subject to young girls. In the year 2018 in order to provide specialized knowledge in Economics, we started Economics honours. Kanoria PG Mahila Mahavidyalaya, Jaipur, a pioneer institution for women education in Rajasthan, has become one of the few colleges in Rajasthan which is accredited by NAAC (UGC).

The Centre for Environment and Development Studies, Jaipur (CEDS) was registered as a centre for research training and action to help poor and marginalised section to the society in the year 2008. The academic staffs have a long experience of work on a wide range of development issues. The main functional areas are: Natural Resource Management and Environment, Economic Policies and Strategies, Social Policies: Institutions, Governance and Civil Society.

1. Objectives of the MoU:

- a) To promote and enhance academic interest between the two institutions.
- b) To seek advice for the quality research at our college.
- c) To encourage bright students of our college to excel in research and projects.
- d) To promote research/ continuing education activities in the college.

2. Technical areas of Collaboration:

- a) A Continuing Quality Improvement Programme and formation of an expert Research committee.
- b) Seek academic interaction by delivering Special Lectures at the college on topics related with Development Economics.
- c) To facilitate trainings for the teachers.
- d) Sharing of Research supervisors, resources and infrastructure.
- e) To provide summer and winter training for our Honours students.

3. Areas of Research Cooperation

- a. Development studies
- b. Environmental studies
- c. Gender studies
- d. Public Policies

4. Exchange of Information and Research Samples

The term "information" includes technical data, results, methods of investigation and data collection, and other information regarding the area of mutual interest. The parties shall take all measures to protect the secrecy of and avoid disclosure and unauthorised use of information which is confidential and outside the public domain.

5. Publications and Intellectual Property Rights

Any research publications and intellectual property rights arising out of the students and joint research projects shall be jointly published and, when patented will be jointly and equally owned by both the parties.

The procedural formalities for securing and maintain the intellectual property rights shall be the responsibility of both parties and the expenditure incurred thereof shall be borne jointly and equally by both parties.

The upfront fee and royalty accrued from licencing of any intellectual property arising from this collaboration to other parties shall be shared between the parties, the terms and conditions of which shall be the subject matter of a separate agreement between the parties.

- a. The Advisory Committee shall meet at least twice in a year either of the two institutions to review the progress.
- b. Based on education, training and research requirements of students and staff, the advisory committee shall in consultation with the faculty decide on areas of research and the mode of cooperation for each of the academic years during the tenure of this collaboration.
- c. The convener and co-convener shall be the contact person for all the cooperation and other related issues identified.

7. Finance

Each party shall bear the respective costs of carrying out the obligations under the agreement. Neither party shall make a claim against the other party for any expenditure unless such expenditure has been agreed upon in writing between the parties.

8. General Provisions

- a. Infrastructure and library facilities available at the party's work place shall be made available to the faculty, research scholars and students of the parties.
- b. The parties shall not use any of the confidential information which is required to be held in confidence for any purpose other than performance of their obligations under this understanding.
- c. The implementation of the areas and forms of cooperation identified under sub-heading 2 and 3 shall be subject to the availability and convenience of research students, faculties and infrastructure facilities available at the parties' work places.
- d. There shall be exchange visits by faculty members and students for academic and research purposes.
- e. All questions related to this understanding arising during its term shall be settled by the mutual agreement between the parties.
- f. Nothing in this understanding is intended to affect other cooperation or collaboration between the parties.
- g. All the collaboration activities pursuant to this agreement shall be conducted in accordance with the laws and regulations governing both the parties.

9. Entry into effect and termination

This MOU shall become effective on the date it is signed by the parties and shall be valid for three years. With mutual agreements amendments can be done. All joint activities not completed at the time of expiration or termination of this agreement may be continued until their completion under the terms of this understanding.

10. Amendments

This MOU represents the entire understanding between the parties and supersedes any and all understandings either oral or written hitherto with respect to the subject matter of this understanding. No amendments or modification shall be valid unless the same is made in writing by both the parties and specifically stating the same to be an amendment of the MOU. The amendments shall become part of MOU and shall be effective from the date on which they are made unless otherwise agreed to.

11. Non-exclusivity

The relationship of the parties under this understanding shall be non-exclusive and both parties are free to pursue other agreements or collaborations of any kind.

This MOU has been executed in two originals, one of which has been retained by Kanoria PG Mahila Mahavidyalaya, Jaipur and other by CEDS, Jaipur. The consent has been taken from The Principal, Kanoria PG Mahila Mahavidyalaya, Jaipur and the Director CEDS, Jaipur.
