



**Memorandum of Understanding (MoU)**

This Memorandum of Understanding (Hereinafter MoU) is between **Kanoria P.G. Mahila Mahavidyalaya, Jaipur** and NGO (Non-Government Organization) named **Abhyutthanam Society**. **Kanoria P.G. Mahila Mahavidyalaya, Jaipur** is running and having its registered office at **Gandhi Circle, Jawahar Lal Nehru Marg, Jaipur- 302015 (Rajasthan)** through its authorized signatory **Dr. Seema Agrawal (Principal)** and **Abhyutthanam Society**, through its authorized signatory **Mr. Pranjal Singh (President)**, seeks to collaborate and sign this MoU in the interest of serving the society and work for the benefit and welfare of deprived section.

**Kanoria P.G. Mahila Mahavidyalaya, Jaipur** is an institution of higher education for women, affiliated to the University of Rajasthan, Jaipur imparting holistic education and offering Undergraduate and Postgraduate Programmes in Arts, Commerce and Science. The NGO, **Abhyutthanam Society**, works with underprivileged children of Kachchi Basti and other deprived areas.

**Kanoria P.G. Mahila Mahavidyalaya, Jaipur** and **Abhyutthanam Society**, agrees to the following towards fulfilling the above stated mutual interest.

1. **Kanoria P.G. Mahila Mahavidyalaya, Jaipur** will work for the upliftment of identified rural area in collaboration with **Abhyutthanam Society**, which will focus on addressing the objectives of the MoU. The details of program will be decided jointly on mutually agreed terms and conditions.
2. **Kanoria P.G. Mahila Mahavidyalaya, Jaipur** and **Abhyutthanam Society** will initiate and conduct any other program or event with mutual consent and as deemed fit towards achieving the common goals.

**Terms of Reference**

This MoU shall become effective from the date of signing by both parties and shall be reviewed every three (3) year thereafter, unless either sides notify, in writing, the other of its intention to terminate it. The terms of MoU, may be varied by the mutual consent of both parties in writing.

Either party may terminate the agreement in advance of its normal expiration/ review by providing the other party with six (6) months prior written notice. In this case, the program or the activity already approved by both parties shall be allowed to be completed under the conditions of this MoU.
