

**Student Mobilisation Initiative for Learning through Exposure (SMILE) Programme**

This is a bilateral agreement between Pravah and Kanoria Mahila Mahavidyalaya, Jaipur  
This MOU is for the **SMILE** programme, effective from 1st May 2024 to 30<sup>th</sup> June 2025.

**1. About Pravah**

Pravah is a non-profit society registered under the Societies Registration Act. Its vision is to co-create a sustainable national ecosystem that nurtures empowering spaces with and for young people, through joint programming and partnerships, capacity building of people and organizations; and engaging with multiple stakeholders in the adolescent and youth space- focusing on youth development and youth-centric development issues.

**2. About Kanoria Mahila Mahavidyalaya**

Kanoria PG Mahila Mahavidyalaya has completed 59 years of its dynamic journey with an aim to educate, emancipate and empower young women. The college exists in the aesthetic environs of Jawahar Lal Nehru Marg established in 1965, by Late Shri Bhagirath Kanoria as the first institution of higher education for women through grant – in – aid from Government of Rajasthan. The college has emerged as one of the leading institutions with NAAC Accreditation and AICTE approved, not only in Jaipur but also in the State of Rajasthan. With a view to impart education the college not only aims at disseminating knowledge and facts, but also emphasizes on value based holistic development. In the SMILE In-turn ship, we place young people (18-29 years) for 2-4 weeks with the non-governmental organizations/ social movements in Rajasthan. We believe that this exposure to the ground realities of the country will allow you to form your own opinion, differentiate facts from fiction, and at the same time, provide the host organization with a helping hand on different projects through specific skills of the volunteer(s). Participants work with young people from different borders to learn about social issues such as gender and religion, and to gain important insights about themselves while volunteering; exploring their self, beliefs, ideas and comfort zones. In Youth Addas, we create a space through a 1-3-hour workshop, where young people can hang out, make friends, get heard, engage with issues close to their heart, discuss and learn through theater, film, music, art, simulation exercise, games, etc. It helps enhance their ability to build their own perspective on issues and realities around them and take informed stances.

#### 4. Intent and Scope of the MoU

Pravah, as part of the SMILE programme wishes to offer students at the college to participate in various opportunities including SMILE In-turn-ship & Youth Addas. The In-turn-ship will be organized twice or thrice in the duration of the MoU. The Youth Addas can be organised once a month or as mutually agreed upon by both organizations.

#### 5. Roles and Responsibilities

Pravah will be working with a designated Kanoria Mahila Mahavidyalaya anchor to ensure that the specific programme commitments for SMILE are met through high-quality interventions. In order to do this, the concerned institution is expected to look at the below roles and responsibilities-

Timely communication and escalation as and when required	Sharing credit in all official communication (online and on-ground) with regards to the SMILE programme and its impact where applicable.
Sharing credit in all official communication (online and on-ground) with regards to the SMILE programme and the role of the college in the same.	Timely communication and escalation as and when required

You will be responsible to notify Pravah if it proves necessary in case of any changes or delays in the activities and in any changes in the office and contact address, the Director and/or Programme Coordinator and of any crisis.

#### **6. Finances**

There are no financial implications on The Institution with regard to this workshop. All financial implications of stationery, travel for facilitators and other occurrences would be borne by Pravah. However, the Institution can choose to contribute voluntarily to the programme.

#### **7. Contract Tenure & Termination**

- The term of this MoU is for the period from 1st May 2024 to 30th June 2025.
- If The Institution is unable to meet the expectations of any of the responsibilities listed above, Pravah would intervene to find possible solutions. If there are no solutions, this programme would be terminated.
- Should The Institution or Pravah desire to terminate the contract, a notice period of one month would need to be given, and a review/feedback be done before this contract is then terminated.

#### **8. Prevention of Sexual Harassment and Child Protection Policy**

Pravah assures complete confidentiality in cases of sexual harassment of the affected party, of the accused, and also of the person who reports the act, in so far as it does not interfere with its obligation or ability to investigate the allegations of misconduct. In the case of this agreement, Pravah will bear full responsibility for sexual harassment allegations against any of its employees during the course of this engagement. Pravah will bear no responsibility with regard to allegations, if any, against you or against employees of other organizations that you may enter into partnership with during the course of this engagement.

Pravah is committed to promoting the rights of children including their right to be protected from harmful influences, abuse, and exploitation. Pravah takes active measures to ensure children's rights to protection are fully realized.

While this contract is based on your commitment to having and committing to its existing sexual harassment and child protection policies as an integral component of this engagement, any violation of the policy and/ or the law will trigger the termination of this agreement.

#### **9. Media Consent**

For all photography, videography and documentation purposes, Pravah has a media consent policy. The attached policy will have to be signed prior to the programme, by the part organization/institute as well as Pravah based on which, Pravah will use the content as per its requirement on social media, which includes its website, Instagram, Facebook, Twitter and Linked in or any other platform, as deemed appropriate.

#### 10. Dispute and Governing Law

In the event that any dispute arises in relation to this MoU, the Parties agree that the matter will be resolved, if possible, by amicable negotiations. Any changes to this MoU must be agreed to by both Parties in writing and attached to the signed copy of this MoU. Each of the parties agrees that it will keep confidential, and not disclose to external parties, any confidential information obtained during or in relation to this MoU except insofar as necessary to comply with any legal requirement.

#### 11. Contact Persons

Kanoria Mahila Mahavidyalaya will be in direct communication with \_\_\_\_ for SMILE, Pravah who will be anchoring this programme from our end. All communication will need to go through her, and she will be the first point of contact with regard to the SMILE programme. 


