**Objectives:**

**Duration:**

3.2 Kanoria College shall:

a) Provide suitable venues and necessary facilities for conducting the workshops.

b) Coordinate with Rotary Club to align the workshop content with the college's curriculum and priorities.

c) Encourage student participation and facilitate their involvement in the workshops.

## Intellectual Property:

4.1 Any intellectual property rights associated with the workshops shall remain with the respective owners, and no party shall use or distribute such intellectual property without prior consent.

## Confidentiality:

5.1 Both parties agree to treat any confidential information shared during the collaboration as strictly confidential and not disclose it to any third party without the other party's written consent.

#### Termination:

6.1 Either party may terminate this MoU by providing written notice to the other party at least fifteen days prior to the intended termination date.

#### Amendment:

7.1 Any amendments to this MoU shall be made in writing and signed by both parties.

#### **Entire Agreement:**

8.1 This MoU constitutes the entire agreement between the parties regarding the subject matter hereof and supersedes all prior discussions, understandings, or agreements.
