



A Memorandum of Understanding
Between
Jaipuria Institute of Management, Jaipur
And
Kanoria PG Mahila Mahavidyalaya, Jaipur

Whereas Jaipuria Institute of Management-Jaipur, established under the affiliation of All India Council of Technical Education (AICTE-Government of India) and having the address at 1, Bambala Institutional Area, Pratap Nagar, Sanganer, Jaipur (herein after referred to as "JIM-J") and Kanoria PG Mahila Mahavidyalaya, Jaipur established under the affiliation of University of Rajasthan and having the address Near Gandhi Circle, J.L.N Marg, Jaipur (herein after referred to as "Kanoria College, Jaipur") seeking to improve understanding between their respective academic institution and to establish a mutually beneficial collaboration benefiting their students and faculty, have agreed to sign this Memorandum of Understanding (hereinafter referred to as the "MoU") as a first step toward achieving these shared goals.

NOW THEREFORE PURSUANT THERETO, the Parties hereby agree as follows:

1. SCOPE AND FIELDS OF ACADEMIC COOPERATION

(1) The Parties hereby agree to implement within the framework of the rules and regulations applicable in each of the institutions and subject to availability of funds and resources, the following programs and activities, which may include, but not limited to:

- (i) Joint conferences, FDPs and workshops including venue sharing. These activities may be conceived, planned and executed collaboratively;
- (ii) Student development programs including One Day MBA for MBA aspirants. The aspirants may be assigned a faculty mentor that shall help the student seek the right MBA institute;



- (iii) Faculty exchange;
- (iv) Faculty collaborative teaching;
- (v) Faculty collaborative research;
- (vi) Knowledge sessions on contemporary issues by faculty from Kanoria College to be organized at Jaipuria institute, under the aegis of CMC;
- (vii) Mentoring Workshop at Kanoria for faculty;
- (viii) Student exchange of Student Council Members;
- (ix) Jaipuria entrepreneurship aspirants make seek the advantage of a registered incubation center at Kanoria College in order to obtain funding and assistance; and
- (x) Library resource sharing (if does not violate the existing licensing arrangements).

The list is suggestive and not exhaustive. There may be a sharing of any other programme or activity leading to academic synergies between both organizations.

(2) It is agreed that the terms and conditions of any agreed programme and activity contemplated in this MoU shall be the subject matter of separate written agreements to be negotiated and agreed upon by both Parties and/or any third parties, wherever applicable. PROVIDED ALWAYS the decision whether to initiate and/or implement any

programme or activity shall be at the sole discretion of each Party.

(3) The Parties agree to designate, on behalf of each institution, a coordinator whose responsibility will be to supervise the execution of this MoU and to draw up programs or activities to be implemented under this MoU, setting out specific provisions concerning the programs. For this purpose, the coordinator for JIM-J is the **Dr. Swati Soni** and for Kanoria College, Jaipur is Dr. Ranjana Agarwal.

2. CONFIDENTIALITY

(1) The Parties agree and undertake to keep confidential at all times any information or data that may be exchanged, acquired or shared in connection with any programme or



activity conducted pursuant to this MoU save where the same is already in public domain.

3. DURATION AND TERMINATION

(1) This MoU shall take effect on and from the date of execution of this MoU and shall continue to be effective for a year therefrom. This MoU may be extended for such further period as may be agreed by the Parties in writing.

(2) Notwithstanding clause 3 (1) above, this MoU may be terminated by either Party giving written notice to the other at least one month prior to the proposed date of termination.

(3) Notwithstanding clause 3 (2) above, the provisions of this MoU or any other written agreement in respect of any on-going exchange programme or any other form of cooperative activity under this MoU shall continue to apply until their completion unless both Parties mutually agree in writing to the earlier termination of the programme or cooperative activity.

7. MISCELLANEOUS

(1) This MoU may be modified, varied or amended at any time after due consultation and with the written agreement of both Parties.

(2) This MOU is not intended to be legally binding. It merely expresses the intentions and understanding of the Parties which will form the basis of any legally binding agreement to be drafted and executed in the future.

(3) The Parties hereby agree that they are not bound exclusively by this MoU and shall be at liberty to enter into any separate agreements or arrangements with any third party without reference to the other Party.
